PERMANENT SUPPORTIVE HOUSING (SHP). SHP IS AN INNOVATIVE PROGRAM WHOSE GOAL IS TO PROVIDE A SUPPORTIVE ENVIRONMENT FOR HOMELESS FAMILIES WHILE HELPING THEM ATTAIN THE HIGHEST LEVEL OF SELF-SUFFICIENCY. TO MEET ELIGIBILITY REQUIREMENTS, THE FAMILY MUST BE HOMELESS AND COME FROM PLACES NOT MEANT FOR HUMAN HABITATION SUCH AS CARS, PARKS, SIDEWALKS AND ABANDONED BUILDINGS; AN EMERGENCY SHELTER; OR A TRANSITIONAL HOUSING PROGRAM FOR HOMELESS PERSONS THAT ORIGINALLY CAME FROM THE STREETS OR EMERGENCY SHELTER. IN ADDITION, ONLY HOMELESS FAMILIES WITH ONE OF ITS MEMBERS HAVING A QUALIFYING DISABILITY ARE ELIGIBLE FOR THE SHP PROGRAM. THIS PAST YEAR SAMMINISTRIES HOUSED 99 HOUSEHOLDS MADE UP OF 328 FORMERLY HOMELESS INDIVIDUALS.

TRANSITIONAL SERVICES - TRANSITIONAL LIVING AND LEARNING CENTER (TLIC) AND TRANSITIONAL HOUSING (TH): IN 2000, WE EXPANDED OUR PROGRAMS AND FACILITIES TO INCLUDE TRANSITIONAL HOUSING FOR FAMILIES AT THE TRANSITIONAL LIVING AND LEARNING CENTER (TLIC) ON BLANCO ROAD. WE ALSO HAVE 25 SCATTERED SITE HOUSES. BOTH PROGRAMS ALLOW UP TO 65 FAMILIES WHO MEET SPECIFIC CRITERIA TO STAY FOR UP TO 24 MONTHS. OUR FAMILIES ARE OFFERED CLASSES INCLUDING: LIFE-SKILLS BUILDING, MONEY MANAGEMENT, PARENT NURTURING, RESUME WRITING, AND GED EXAM READINESS. IN FY 2013, THE TLIC AND TH PROGRAMS PROVIDED SAFE HOUSING FOR 136 FAMILIES (453 INDIVIDUALS).

HOMELESS PREVENTION SERVICES - SAMMINISTRIES HAS BEEN WORKING WITH THE GENERAL COMMUNITY IN ADDRESSING THE BARRIERS THAT CONTRIBUTE TO FAMILIES AND INDIVIDUALS BECOMING HOMELESS. THESE BARRIERS ARE BEING ADDRESSED THROUGH COMMUNITY COLLOBORATION AND THROUGH PROVIDING DIRECT FINANCIAL ASSISTANCE TO FAMILIES AND/OR INDIVIDUALS WHO QUALIFY FOR RENTAL AND UTILITY ASSISTANCE. IN FY 2013, SAMMINISTRIES PREVENTED 1,289 FAMILIES (2,934 INDIVIDUALS) FROM BECOMING HOMELESS. WITH A COMBINATION OF PRIVATE AND PUBLIC FUNDING, SAMMINISTRIES HAS BECOME THE LARGEST PROVIDER AND COMMUNITY LEADER IN THE AREA OF HOMELESS PREVENTION SERVICES.
