PERMANENT SUPPORTIVE HOUSING PROGRAM (PSH): PSH IS AN INNOVATIVE PROGRAM WHOSE GOAL IS TO PROVIDE

A SUPPORTIVE ENVIRONMENT FOR HOMELESS FAMILIES AND INDIVIDUALS WHILE HELPING THEM ATTAIN THE HIGHEST LEVEL OF SELF-SUFFICIENCY. TO MEET ELIGIBILITY REQUIREMENTS, THE FAMILY MUST BE HOMELESS AND COME FROM PLACES NOT MEANT FOR HUMAN HABITATION, SUCH AS CARS, PARKS, SIDEWALKS AND ABANDONED BUILDINGS; AN EMERGENCY SHELTER; OR A TRANSITIONAL HOUSING PROGRAM FOR HOMELESS PERSONS THAT ORIGINALLY CAME FROM THE STREETS OR EMERGENCY SHELTER. IN ADDITION, ONLY HOMELESS FAMILIES WITH ONE OF ITS MEMBERS HAVING A QUALIFYING DISABILITY ARE ELIGIBLE FOR THE SHP PROGRAM. SAMMINISTRIES HOUSED 213 HOUSEHOLDS INCLUDING 281 ADULTS AND 142 CHILDREN DURING THIS FISCAL YEAR.

CREDIT/CRIMINAL HISTORY, LACK OF INCOME/EMPLOYMENT, DISABILITIES, OR SUBSTANCE USE DOES NOT LIMIT PARTICIPATION. ONCE HOUSED, CLIENTS ARE OFFERED INDIVIDUALIZED CASE MANAGEMENT SERVICES TO ASSIST THEM IN INTEGRATING IN THEIR NEIGHBORHOOD, ACCESSING NEEDED MENTAL/PHYSICAL HEALTH SERVICES AND SECURING INCOME/BENEFITS FOR WHICH THEY ARE ELIGIBLE. ALL PARTICIPANTS HAVE ACCESS TO EDUCATIONAL ASSISTANCE PROVIDED BY SAMMINISTRIES, INCLUDING FINANCIAL ASSISTANCE WITH EDUCATIONAL AND VOCATIONAL PROGRAMS AND/OR COLLEGE SCHOLARSHIPS. THIS PROGRAM SERVED 152 FORMALLY HOMELESS HOUSEHOLDS (299 INDIVIDUALS) THIS FISCAL YEAR.
